**Order:**

In exercise of the powers conferred under Section 30 of the Tamil Nadu Regulation of Rights and Responsibilities of Landlords and Tenants Act 2017, (Tamil Nadu Act 42 of 2017) which has come in to force from 22.02.2019 and in pursuance of the letters referred above, I do hereby appoint the following Officials as Rent Authority to the concern Divisions, in the District of Tiruvannamalai.

The aforesaid respective officers shall function as the Rent Authority prescribed under the aforesaid Tamilnadu Act 42 of 2017 in respect of all the urban areas falling within their respective territorial jurisdiction with effect from the date of this order.
